

Regulations for Jokkmokk Winter Market 2020

All vendors must read our regulations and follow them.

Market area

The market area is arranged to facilitate market sales as well as for some activities provided by the market organizer. The vendors must be at their market stalls during all three days between 10 am and 6 pm.

Opening hours: Thursday, Friday and Saturday 10:00-18:00

During the opening hours all market stalls must be open with items for sale. It is against the rules to close the stall in advance. For safety reasons you are not allowed to drive cars or other vehicles into the market area while the market is open. Any exceptions to this must be made in consultation with the market organizer.

Food sales

Information and forms relating to food sales can be found on the website or may be ordered from the market organizer.

Assortment

The assortment of products for sale must be consistent with what has been specified on the application form, otherwise the seller may be asked to leave the market. In each individual case, the market organizer decides whether the requested assortment/activity will be allowed in Jokkmokk's market.

Jokkmokk market's set of values are based on diversity, respect and the equality of all. We don't allow discriminatory products or activities or any goods containing pictures or text which are drug-related or encourage violence.

Sign with the name of the enterprise

A sign which includes information on how to get in touch with the vendor should be prominently placed on the stand.

Electricity

The vendors are responsible to bring approved high-quality electrical equipment. The organizer is entitled to cut off the power if the equipment causes problems to others or poses a risk of personal injury. We can only provide electricity to those who have ordered it in advance.

If there are left-over outlets and capacity, access to them can be purchased on the spot. If you use electricity without paying for it, you will be asked to leave. Please bring the plastic tag you will receive when you place your order and attach it to the cord.

Take note that we can only provide electricity during the market from Thursday morning to Saturday evening.

The law concerning the mandatory use of cash registers.

Market spots

We need your application form by October 15th, 2019. Please fill in the Jokkmokk market form. You can order it from the organizer or download it from the website. We send the confirmation and the bill when all the spots are distributed.

Payment and cancellations

If you have been assigned a market spot and are hindered from coming, please contact the organizer at once, otherwise the market spot must be paid for, anyway.

If you need to cancel a market spot, you must do so at least 4 weeks in advance of the market opening. In cases due to sickness or serious car problems, a refund can be made if you send us a certificate proving it. (An administrative fee of 200 SEK will be deducted.) Market spots may not be subleased between vendors without permission. The organizer has the right to discontinue the vendor who has borrowed the spot as well as the one that is registered for it, if the lending/selling has been done without the organizer's approval.

Schedule for putting up the market stall

On Wednesday from 12:30-20:00 and on Thursday from 07:00-10:00 you can set up your stall and unpack your products. During these hours you'll find staff at the market area. At 10:00 on Thursday you must be ready to open you stall.

Area H shall be completely free of vehicles, trailers and caravans throughout the market because the stage will be used during the market days. When it comes to accommodation, we refer everyone with a caravan, camper/bus to the Campsites.

Regulations from the Fire & Rescue service

- *The distance between caravans and mobile homes should at least be 4 meters.
- *There must be 4 meters between the façade of any building and the stall.
- * Emergency services, medical staff and police vehicles must be able to access the area around the clock throughout the Market without difficulty.
- * All fire hydrants and equipment showing the location of the equipment must not be blocked.
- * All safety regulations relating to fire and electrical safety must be met by every vendor.
- * Use of LPG must be indicated at the time of application
- * When using more than 2 containers of P11, you must send an application to the Fire & Rescue service.
